### INTRODUCTION

The mission of DASH is to ensure access to safe and sustainable refuge for domestic violence (DV) survivors in the District of Columbia. We do this through the development and management of safe housing and by supporting survivors in finding safe housing options for themselves and their children.

It takes a tremendous amount of courage for a survivor to leave an abusive relationship. When there appears to be no safe place to escape to, the situation can feel even more overwhelming. Often survivors feel that they must choose between living without a home and living without abuse. This is why DASH prepared this housing resource guide - to provide comprehensive housing program information (including application and eligibility requirements) so that survivors feel they have more control over their housing search.

If you are a survivor in immediate danger, call 911. If you are planning your escape, be sure to keep this guide in a safe place. In the back of this guide is a safety plan. Having a safety plan is a way for you to literally plan to keep yourself safe when living in an abusive relationship and when planning your exit. You can also reach out to counselors at any of the domestic violence programs listed in this guide for support.

What you will find in this guide:

- Information on domestic violence emergency and transitional housing programs in DC, as well as a selection of programs in Maryland and Virginia.
- Information on housing programs that are not specifically for DV survivors, but can still provide a safe place to live for women seeking safety.
- Detailed information for each housing program so survivors can know exactly what services are provided, what the eligibility requirements are, if the program is accessible to people with disabilities, and how to apply.

# TIPS

## TIPS FOR SURVIVORS READING AND USING THIS GUIDE

- If you are unclear about whether you are part of the population the program serves, call and ask. For example, some domestic violence (DV) programs include survivors of elder abuse, LGBT survivors and those escaping prostitution in their definition of DV. Similarly, some programs require survivors be in imminent danger, while others (usually transitional housing programs) require that survivors have experienced abuse within the last five years.
- Make sure you are clear about whether the services and referrals offered to you are voluntary or if you are required to participate as a condition of your residency in the program. For example, some programs require that you attend support groups, counseling sessions, and follow-up on the referrals given you. If this is the case, be sure to ask if there is any flexibility - especially if you have a night job or a schedule conflict that would prevent you from participating in mandatory evening groups.
- Double check with programs if you have a boy over the age of 12 and want to bring him with you, because several programs have an age limit in place for boys. Typically this policy exists in programs that have communal space where families share bedrooms. Depending on who is in the housing program at any given time, boys over 12 may be accommodated.
- You might want to ask if you'll be assigned a caseworker or advocate who will support you in finding resources, and if so, ask how often you will be meeting with them.
- You might want to ask if there is any flexibility with program time limits – most offer extensions if you haven't found housing.
- Many of the housing programs listed in this guide require a referral from a case manager as part of their admissions process. If you are a survivor of DV and you don't have a case manager or advocate, you can call DASH at 202.742.1728 and a Housing Advocate can assist you by making housing referrals for you and providing housing counseling.

## TIPS FOR ADVOCATES READING AND USING THIS GUIDE

- This guide is meant to be used to assist you in helping your clients find emergency, transitional and permanent supportive housing.
- We focused on gathering information on DV housing programs and programs that serve women and children. Thus, this is not an exhaustive list of all available housing programs, particularly of those that serve people with a mental illness or have a history of substance abuse. # GLOSSARY

## GLOSSARY OF TERMS USED IN THIS GUIDE

Below are definitions for the categories under which we organized the housing program information we gathered for this guide.

**Population:** This section details the specific group of people the program serves. DV programs typically only serve women survivors of DV. Often programs for homeless women serve a broader group of women in need of housing, including women in recovery and women with mental illness. Some programs serve both women with children and single women, while others will only serve one group or the other. Several housing programs do not admit boys over the age of 12, while other programs are more flexible.

**Services:** This section details the services available at the housing program. Support groups and counseling for survivors and their children are often available at DV programs, along with other services that assist survivors with coping with the trauma from experiencing DV. Often programs have case managers or advocates that help participants obtain necessary public benefits and provide referrals to job training programs, food banks, mental health support and others.

**Admission Process:** This section explains the process one will need to go through in order to apply for and obtain entry into the program. For DV programs, survivors are usually asked to call a 24-hour crisis hotline and speak directly with an advocate who will conduct an intake interview over the phone. Some processes are more involved than others and may require information from a case manager or a referral from the Virginia Williams Family Resource Center (see page 14).

**Eligibility Requirements:** This section outlines what the program requires of each applicant in order to be considered an appropriate candidate. For example, some programs require the applicant be drug and alcohol free, employed, have documentation of homelessness, or be willing to participate in a mandatory savings program.

**Residency Requirements:** This section states whether the program will accept an applicant from DC, and if so, under what conditions, if any.

**Wheelchair Accessible:** This section states whether a program can accommodate people who use a wheelchair.

# EMERGENCY DOMESTIC VIOLENCE HOUSING

## EMERGENCY DOMESTIC VIOLENCE HOUSING:

Emergency domestic violence (DV) housing programs offer a safe place for survivors and their children to escape to in a crisis situation. These housing programs are often different from what you might imagine a typical homeless shelter to look and feel like. The location of a DV housing program is usually kept confidential and residents are asked not to disclose the address to anyone, including friends and family. This means that residents can't have visitors, and they must be dropped off and picked up several blocks from the housing program. Typically these programs serve women and those who identify as women, although more and more programs are increasing their capacity to serve male victims as well.

Emergency DV housing programs are usually in home-like settings. Depending on the space, sometimes residents have their own room or they must share a room with another resident and possibly her children. Responsibilities like cleaning and meal preparation are shared. Typically the length of stay in emergency DV programs is 45 days; however, most programs are flexible depending on when a woman secures transitional or permanent housing.

At emergency DV housing programs, advocates are on staff to support survivors and their families to obtain the information and resources they need to gain stability and heal from the abuse by providing the following support:

- Referrals for obtaining protection orders and legal assistance.
- Assistance obtaining important documents like: birth certificates, social security cards, driver's licenses, etc.
- Help applying for public assistance and housing subsidies.
- Referrals to mental health and addiction services.
- Assistance enrolling children in nearby schools.
- Counseling and support groups for women and their children.

The Crime Victims Compensation Program (CVCP) at the DC Superior Court offers another emergency housing option for many survivors in DC. This program is particularly useful when DV housing programs are filled to capacity. The CVCP assists DV survivors who applied for a protection order or filed a police report in DC to obtain emergency safe housing through the provision of a hotel voucher for a specific amount of time (usually 28 days). There are limited DV safe housing options in DC. A survivor who requires safe, confidential housing might consider DV safe housing programs in Virginia and Maryland. The following sections lists the emergency DV housing options in DC and select programs in Maryland and Virginia.

**POPULATION SERVED:** Single women and women with children.

**SERVICES:** Discreetly located emergency and transitional housing. Duration of program is 6-24 months; individual advocacy, referrals, children's programs, wellness programs.

**ADMISSION PROCESS:** Written (please fax) or phone referral from a case worker; self-referrals welcome. Admission is based on space availability. If space is available, the woman will be called back and basic information will be collected over the phone. Upon arrival, an intake will be completed.

**ELIGIBILITY REQUIREMENTS:** Must be a DV survivor.

**WHEELCHAIR ACCESSIBLE:** YES

**POPULATION SERVED:** Women with children. Male children must be 12 years old or under.

**SERVICES:** Confidential emergency housing; 24-hour crisis hotline; legal and job assistance; crisis intervention; support groups; individual counseling; case management; referrals; and children's programs.

**ADMISSION PROCESS:** Call the hotline to have a phone interview. If there is availability, staff will notify the woman within 24 hours. Once notified, a woman has 12 hours to get to the facility and claim the space. Staff will work with each woman on creating a plan to meet her in a safe place to bring her and her children to the facility.

**ELIGIBILITY REQUIREMENTS:** Must be a DV survivor; must be drug and alcohol free.

**WHEELCHAIR ACCESSIBLE:** Yes.

**ADMISSION PROCESS:** Call hotline to be assessed by a counselor.

**POPULATION SERVED:** Single women; women with children. Male children must be 12 years old or under.

**SERVICES:** Emergency housing for 90 days; transitional housing for 18 months; 24-hour crisis hotline; individual counseling; crisis intervention; rape crisis center; incest survivor support; abuser intervention program; workshops; HIV/AIDS education and prevention program; employment training; displaced homemaker program; and legal services.

### EMERGENCY HOUSING PROGRAM

**ADMISSION PROCESS:** Walk-in for assessment and intake without an appointment. If granted admission to the program, a DV advocate will be assigned to the woman. If admission is not granted, a referral to another agency in the area will be provided.

### TRANSITIONAL HOUSING PROGRAM

**ADMISSION PROCESS:** Women must first go through the emergency shelter program. A counselor will assess the woman again to determine eligibility for the transitional housing program.

**ELIGIBILITY REQUIREMENTS:** Must be a DV survivor; must be drug and alcohol free.

**WHEELCHAIR ACCESSIBLE:** Yes.

**RESIDENCY REQUIREMENTS:** Will consider referrals from DC agencies if space permits.

**NOTES:** Fees for shelter and services based on a sliding scale.

**SERVICES:** Emergency housing for up to 45 days; transitional housing for up to 6 months; case management; counseling; advocacy; support groups; outreach and community education; legal assistance for victims and their families; and New Behaviors abuser intervention program.

### EMERGENCY HOUSING PROGRAM

**ADMISSION PROCESS:** Women should call the hotline and an assessment is conducted over the phone. If approved, a meeting will be scheduled with the woman and a case manager to sign a contract.

### TRANSITIONAL HOUSING PROGRAM

**ADMISSION PROCESS:** Women must have stayed in the emergency shelter to be considered for the transitional housing program.

**ELIGIBILITY REQUIREMENTS:** Must be a DV survivor; must be mentally stable; and must be drug or alcohol free. If a woman has a history of substance abuse she must be willing to attend treatment. In addition, for transitional housing, she must be employed.

**WHEELCHAIR ACCESSIBLE:** Yes.

**RESIDENCY REQUIREMENTS:** Program will accept referrals from DC agencies if space permits.

**NOTES:** Services are available in Spanish.

**EMERGENCY HOUSING ADMISSION PROCESS:** Admission is determined on a case by case basis and is granted depending on the amount of space available. Call hotline

to have a phone intake. The average intake process is completed within 20 minutes.

**TRANSITIONAL HOUSING ADMISSION PROCESS:** Participant must have stayed in the emergency housing to be considered for the transitional housing program. The participant must have demonstrated the following in order to obtain transitional housing: A commitment to working toward self-sufficiency; be in need of housing assistance; actively searching for employment, volunteer positions, or job training programs; be in regular contact with the Transitional Services Coordinator; and provide the Council with all information and documents to advocate on their behalf.

**ELIGIBILITY REQUIREMENTS:** Must be a DV survivor; must not pose a threat to self or others; must either work or attend school at least 20 hours per week; must be drug and alcohol free.

**WHEELCHAIR ACCESSIBLE:** Yes.

**RESIDENCY REQUIREMENTS:** Will consider those from DC if space permits and can assist DC women to find housing placement in the Baltimore area.

**NOTES:** Bi-lingual services available.

**POPULATION SERVED:** Single women; women with children.

**SERVICES:** Emergency housing for 28 days (2 confidential safe houses); support groups; referrals to services; court advocacy program; and children's program, and batterers intervention.

**ADMISSION PROCESS:** Those seeking shelter should call the hotline. After 5 PM the calls go directly to the safe house, where a staff person will conduct a phone intake assessment. Before 5 PM the calls go to an answering service. Someone from the safe house will return the call, but they will only leave a message if they are given permission to do so and the phone number is undisclosed. If it is determined that the woman can come to the shelter, she will be given an address to a check in point, where she will call from a pay phone to receive the directions to the safe house.

**ELIGIBILITY:** Must be a DV victim; must be drug and alcohol free.

**WHEELCHAIR ACCESSIBLE:** Yes.

**RESIDENCY REQUIREMENTS:** Will consider those from DC, but callers should try all other housing options in the city before calling.

# EMERGENCY HOUSING

## **EMERGENCY HOUSING (NOT SPECIFICALLY FOR DOMESTIC VIOLENCE SURVIVORS):**

When there is no space available at the domestic violence (DV) safe housing programs, survivors often seek emergency housing at programs for homeless women. These programs provide fewer services and support that relate directly to the impact of DV, and they are usually not located in a confidential location. However, depending on the situation, homeless programs can still be a safe place to go in a crisis and often there are caseworkers there who can assist survivors with finding DV supportive resources and longer term housing.

The following section lists some of the emergency housing options for women in DC.

# TRANSITIONAL DOMESTIC VIOLENCE HOUSING

## **DOMESTIC VIOLENCE TRANSITIONAL HOUSING PROGRAMS:**

Domestic violence (DV) transitional housing programs provide survivors and their children with longer-term stability while offering the heightened level of security that is often required. In transitional housing, survivors typically focus on gaining financial stability so that they can obtain permanent housing. On-going supportive services at these programs address the many underlying issues related to experiencing abuse, such as post traumatic stress disorder, depression and chronic illness. Program advocates provide intensive support around securing employment, achieving financial stability, resolving legal issues and identifying and achieving other goals for long-term stability.

Families in transitional housing programs usually have their own apartments and stay for typically one to two years, depending on the program. The following is a list of transitional housing options specifically for DV survivors in DC.

# TRANSITIONAL HOUSING

## **TRANSITIONAL HOUSING (NOT SPECIFICALLY FOR DOMESTIC VIOLENCE SURVIVORS):**

If you are a survivor who is homeless as a result of domestic violence (DV), you may want to consider transitional housing programs that can provide a safe place to go when there are no other options or available space in DV housing programs. These programs are typically not in confidential locations, and the application process varies from DV transitional housing programs. For single women, programs may require you obtain a referral from an advocate at one of the emergency housing programs listed in the previous section of this guide, or from a nonresidential program. For women with children, many of the programs require applicants to have a “declaration of homelessness” letter. This letter can be provided by:

- a domestic violence advocate;
- an outreach worker;
- a soup kitchen employee; or
- a caseworker at the Virginia Williams Family Resource Center (FRC).

The FRC is the central intake office for all homeless families requesting housing and assistance in DC through the Department of Human Services. You will notice in this section that many of the transitional housing programs for women and their children require that you obtain a direct referral from the FRC, which is located at this new location:

It is advised that you bring: a letter verifying that you’re homeless, a picture ID, birth certificate and social security cards for all family members, documentation of income, and eviction notice if available.

If you are staying in a hotel through the assistance of the Crime Victims Compensation Program (see page 4) and you have dependent children, it is highly recommended that you visit the FRC within the first week of your stay. This is because, depending on available space and individual program admission guidelines, it can take several months until a family is admitted into a transitional housing program. Given that the hotel stay is approximately 28 days, it is advised that you start the process of looking for transitional or permanent housing as soon as possible.

## **SAFETY plan**

If you are planning on fleeing an abusive situation, it is imperative that you try to do it as safely as possible. One way of doing that is by having a safety plan. A safety plan is literally a plan you have to keep yourself safe in various environments and situations. The personalized safety plan below can be filled out or copied for you or someone you know. Please take care to keep it in a safe place, preferably with you, at all times, but if that is not safe find a friend/relative or creative place to store it where your partner will not think to look for it. Your safety plan should be reviewed and updated periodically to keep it current. If you need assistance thinking through your own safety options please contact an advocate at one of the domestic violence programs listed in this guide.

To ensure safety and independence, I can:

## AFTER LEAVING AN ABUSIVE RELATIONSHIP ...

I can change the locks; install steel/metal doors, a security system, smoke detectors and an outside lighting system or I can look for these elements when relocating to a new apartment/house.
